All applications are submitted online via [Google Forms](#).

The deadline to submit is **Friday, March 20, 2026 at 11:59 pm ET**.

The application will request basic organizational information, your operating budget from the past three years, responses to narrative questions, and supporting materials.

It is not possible to save your answers on Google Forms, so we're providing a list of all questions and requested support materials below. We recommend preparing your answers separately and submitting through the form after.

## Application Questions:

### ELIGIBILITY:

1. Has your average annual budget been less than \$500,000 over the past three years? (Yes/No)
2. Are you a 501(c)3 non-profit organization based in the U.S.? (Yes/No)
3. What is your tax I.D. number?
4. If you are not a 501(c)3 non profit organization, do you have a fiscal sponsor? You have entered into a fiscal sponsor agreement if you have agreed to use a nonprofit tax-exempt organization to accept funds on your behalf or accept legal and/or financial responsibility on your behalf. (Yes/No)
5. List the name of your fiscal sponsor below (if applicable)

4. How has your work sought to advance the wellbeing of the MENA community, and how will this grant support your long-term plans to engage with the MENA community in the next two years and beyond? (3000 characters max)

**FINANCIAL INFORMATION:**

1. Please upload your current fiscal year budget, and financials (P&L, Balance sheet, 990s) (Maximum five files)
2. Please upload your financials (P&L, Balance sheet, 990s) for the last two fiscal years

**SUPPORTING MATERIALS:**

Supporting materials are optional, but strongly encouraged.

You may include up to 3 links to work samples.

In the description section for each link, please provide clear information to explain what they are, date, location, and other key information.

Links must either be password-free, or the password must be clearly included in the description of the video.
